OFFICIAL RULES AND REGULATIONS

1. The contest is open to any school or system based GSNA member 18 years or older. Employees of the Georgia Peanut Commission, their affiliates, promotional agencies and their families are not eligible.
2. Recipes must be original and previously unpublished in any cookbook or any distributed recipe or on line. Each recipe must use at least 4-cups peanuts and/or peanut butter as an ingredient per 100 servings. A recipe may be entered in the Lunch Entrée category, Breakfast category or Afterschool Snack category. No Desserts. All entries should be quantity recipes and specify portion size.
3. One prize will also be awarded to the school system that uses the **most poundage of peanuts and/or peanut butter** based on a per student amount during the time period specified. This award application should be submitted directly to the GSNA office at 2372 Main St., Tucker, GA 30084, postmarked no later than March 2, 2026.
4. Entries must be in English and include standard U.S. weights/measures and include a complete list of ingredients, complete preparation directions, pan sizes, cooking times, temperature, and yield.
5. You may enter as many times as you wish, but each recipe must be printed on 8 1/2 X 11-inch paper from a nutrient analysis program. Please include the suggested category (from #2 above) your name, address, e-mail address, phone, school system, and fax number in typed form on the contest cover sheet. Your name must also be typed on the nutrient analysis page.
6. All entries and recipes become the property of the Georgia Peanut Commission and will not be returned. All recipe entries must be submitted to and judged at your GSNA District Culinary Competition, according to the dates and instructions set by your District. Sponsors are not responsible for lost or misdirected mailed entries. The winning "District" Peanut recipes will be judged as part of the GSNA Culinary Competition in March, 14, 2026, Jackson High in Butts County.
7. Recipe judging will follow the criteria on the score sheet used by GSNA.
8. Cash prizes will be as follows: First Place in Lunch, Breakfast and Afterschool Snack categories is \$250, Second place for each category is \$175, and Third place for each category is \$100. The County/ system that uses the most poundage of peanuts and/or peanut butter per student during the time period specified will be awarded a \$1,000 cash prize. Winners will be announced at the GSNA Annual Conference.
9. By submitting an entry, entrant agrees to the use of his/her name, photo and recipe submission in any form of publicity or trade promotion purposed by the Georgia Peanut Commission. The Georgia Peanut Commission reserves the right to adapt, modify, edit and publish the recipes as they deem fitting.
10. The decision of the judges is final in all aspects of this contest.
11. Any local, state or federal taxes are the responsibility of winners.
12. There will be no substitutions of prizes as offered except at the discretion of the Georgia Peanut Commission. Prizes are non-transferable.
13. Prize winners will be required to sign and return an Affidavit of Eligibility, Publicity, Liability and Ownership Release.
14. The contest may be cancelled without penalty should the Georgia Peanut Commission deem it necessary. Winners may not be selected in all categories at the judges' discretion.
15. The Georgia School Nutrition Association will not be paying or reimbursing peanut recipe winners for any hotel, travel or other related cost associated with attending the State Culinary Competition.
